## ARTICLES OF ORGANIZATION OF NJS IV, LLC

The undersigned, being a duly authorized representative of a Member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, does hereby adopt the following Articles of Organization:

#### ARTICLE I

#### $\underline{\underline{\mathbf{M}}\underline{\mathbf{M}}\underline{\mathbf{N}}}$

The name of the limited liability company is NJS IV, LLC (the "Company").

#### ARTICLE II

#### ADDRESS

The principal office and mailing address of the Company

#### ARTICLE III

#### REGISTERED AGENT AND OFFICE

#### ARTICLE VII

#### ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of a majority of the ownership interests of the Company, upon the written application of such new Member, in the manner selfforth in the Operating Agreement of the Company.

#### ARTICLE VIII

#### OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company in the manner set forth in the Operating Agreement of the Company.
