## AMENDMENT TO ARTICLES OF MERGER

Pursuant to Chapter 608, Florida Statutes, AdvanTech Solutions Insurance, L.L.C. hereby adopts and files this Amendment to Articles of Merger.

AdvanTech Solutions Insurance, L.L.C. filed Articles of Merger on December 30, 2003 evidencing the merger of AdvanTech Solutions Insurance, L.L.C. and AdvanTech Solutions Insurance, Inc. (the "Articles of Merger"). The Articles of Merger were effective on December 31, 2003.

A typographical error was discovered in the FOURTH paragraph of the Plan of Merger which is attached to the Articles of Merger. This Amendment to Articles of Merger is filed solely for the purpose of correcting the typographical error in the Plan of Merger.

The FOURTH paragraph of the Plan of Merger incorporated into the Articles of Merger currently provides as follows:

### **FOURTH:**

A. The manner and basis of converting the interests, shares, obligations or other securities of each merged party into the interests, shares, obligations or other securities of the survivor, in whole or in part, into cash or other property are as follows:

By virtue of the merger, and without further action on the part of any party, each share of **AdvanTech Solutions Insurance, Inc.** stock shall convert into one unit of **AdvanTech Solutions Insurance, L.L.C.** as of the Effective Date of the merger. By virtue of the merger, **AdvanTech Solutions Insurance, L.L.C.** shall own 100 units of the L.L.C. which shall constitute 100% of the units of the L.L.C.

B. The manner and basis of converting rights to acquire interests, shares, obligations, or other securities of the surviving entity, in whole or in part, into cash or other property are as follows:
