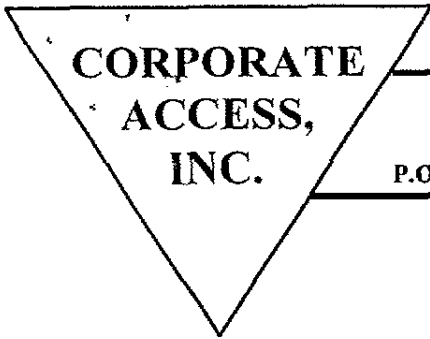



### MEMBERS RIGHTS TO CONTINUE BUSINESS


