
**ARTICLES OF ORGANIZATION**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608):

1. **Name.** The name of this limited liability company is **JIMMBO, LLC** ("Company").
2. **Purpose.** The Company is organized to engage in any business permitted under applicable law.
3. **Mailing Address and Street Address.** The Company's mailing address is 2600 South Ocean Boulevard, #PH-B, Boca Raton, FL 33432. The Company's street address is 2600 South Ocean Boulevard, #PH-B, Boca Raton, FL 33432.

5. **Additional Members.** Additional member(s) to the Company may be admitted, but only if the current Members agree to the admission of the additional member(s) and to the terms of admission.
6. **Management of the Company.** The Company shall be managed by the managers.
7. **Operating Agreement.** Pursuant to Section 608.423 of the Florida Statutes, the Members shall have the power to adopt, alter, amend or repeal an Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
8. **Date of Existence of the Company.** The existence of the Company shall commence on the date of filing the Articles of Organization by the Florida Department of State.
9. **Limitation on Agency Authority of Members.** Pursuant to Section 608.4235 of the Florida Statutes, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no Member shall have authority to incur debt or contractual liability on behalf of The Company solely by virtue of being a member.


