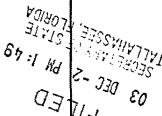

ARTICLES OF ORGANIZATION FOR KNIGHT REAL ESTATE HOLDINGS, LLC A FLORIDA LIMITED LIABILITY COMPANY FILED PURSUANT TO FLORIDA STATUTE §608.407



ARTICLE I

The name of the Company is Knight Real Estate Holdings, LLC.

ARTICLE II
