ARTICLES OF ORGANIZATION

COOL COATINGS, LLC, A Florida Limited Liability Company

- 1. Name: The name of the limited liability company is COOL COATINGS, LLC (sometimes hereinafter referred to as the "LLC.").
- 2. Purpose: The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.
- 3. Address of Principal Office: The address of the registered office of the limited liability company is 5465 Sand Lake Rd., Melbourne, Florida 32934; mailing address: 5465 Sand Lake Rd., Melbourne, Florida 32934. The registered agent at that address is Michael E. Miller.
- 4. Members at Time of Formation: The initial member is Michael E. Miller.
