MANAGEMENT**

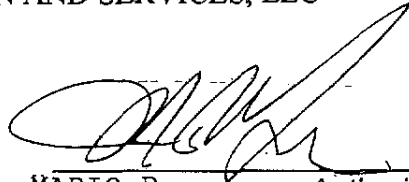
The Company shall be managed by its managers.

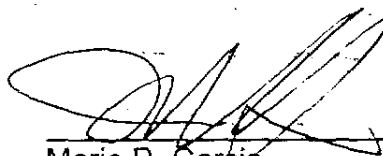
