The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

ARTICLE I

Name

The name of the Limited Liability Company is: **WEB SOURCE HOLDINGS, L.C.**

ARTICLE II

Address of Place of Business

ARTICLE III

Purpose


