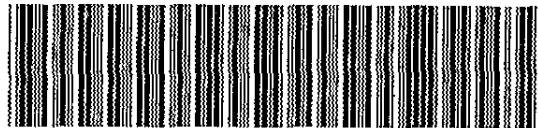

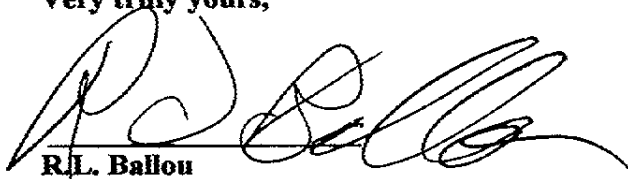

The manager may admit new members in its sole and unfettered discretion subject only to the condition that such additional member must agree in writing to be bound as member by the Operating Agreement of the Company.

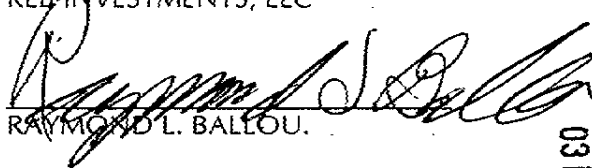
