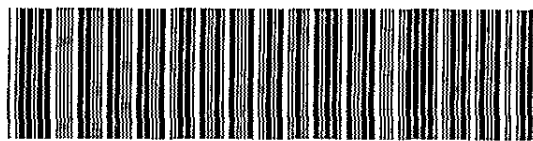

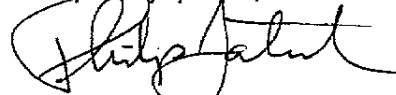

Pursuant to the applicable provisions of Section 608.411, Florida Statutes (2003), **LEEDS/GLENWOOD ARBOR, LLC**, a Florida limited liability company (the "Company"), does hereby amend its *Articles of Organization* as follows:

1. **Date of Initial Organization** - The *Articles of Organization* were initially filed with the Florida Department of State on November 21, 2003, effective November 18, 2003.

**NAME AND PRINCIPAL OFFICE**

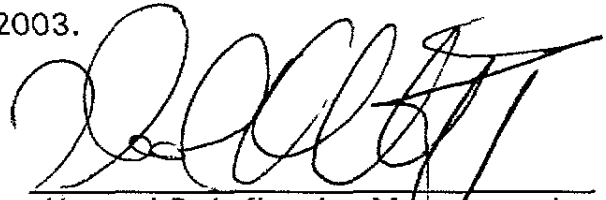
