## ARTICLES OF ORGANIZATION OF

PABEK, Realty, L.L.C.



The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

#### ARTICLE I

#### NAME

The name of the limited liability company shall be PABEK Realty, L.L.C. ("Company"). The principal place and mailing address of business of the Company in Florida shall be 124 Inlets Blvd., Nokomis, Florida 34275.

#### ARTICLE II

#### **DURATION**
