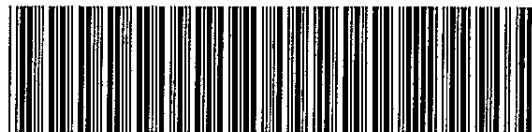

The name of the Limited Liability Company is Staff Services, LLC.

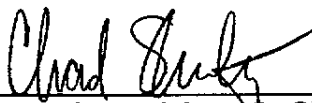

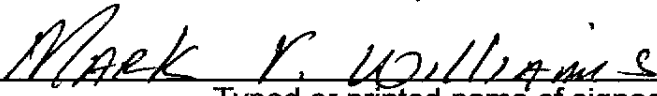
