# AMENDED AND RESTATED ARTICLES OF ORGANIZATION Of

## Karen's Painting, L.L.C.

to change name from Karen Santos, L.L.C. and to add members

Karen Santos, the undersigned, does hereby amend and restate the Articles of Organization, which, originally, were filed on November 24, 2003, with an effective date of November 19, 2003, of this Limited Liability Company, Karen Painting, L.L.C. (formerly known as Karen Santos, L.L.C.), which Limited Liability Company is operating for profit by and under the provisions of the statutes of Florida appertaining and providing for the liabilities, rights and privileges as a Limited Liability Company operating for profit, and, in accordance with Section 608.411 of the Florida Statutes, does hereby duly make, subscribe, execute, acknowledge and file these Amended and Restated Articles of Organization and does hereby declare, state and certify:

#### ARTICLE I.

The name of this Limited Liability Company, formerly known as Karen Santos, EL.C., shall now be known as:

#### ARTICLE II.
