ARTICLES OF ORGANIZATION Of

Karen Santos, the undersigned, does hereby establish for the purpose of becoming a Limited Liability Company, operating for profit by and under the provisions of the statutes of Florida appertaining and providing for the formation, liabilities, rights, privileges as Limited Liability Company operating for profit, and do hereby make, subscribe, acknowledge and file these Articles of Organization for the purpose of becoming such a Limited Liability Company for profit and do hereby declare, state and certify:

ARTICLE I.
