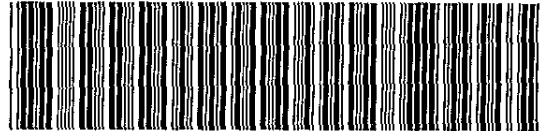



ARTICLES OF ORGANIZATION
OF
