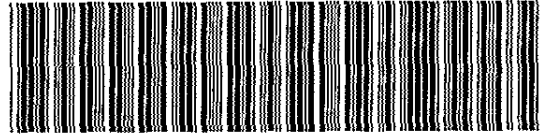

The undersigned, desiring to form a limited liability company under the provisions of Florida Statute 608, as amended, hereby sets forth the following:

**ARTICLE I**  
**Name**

The name of the Limited Liability Company is **RLE INVESTMENTS, LLC**, (hereinafter referred to as the "Limited Liability Company")

**ARTICLE II**  
**Principal Office and Mailing Address**

The principal place of business and mailing address of this Limited Liability Company shall be 4627 Rue Bordeaux, Lutz, Florida 33558.

**ARTICLE III**  
**Duration**


**ARTICLE V**


