ARTICLES OF ORGANIZATION

The undersigned persons, for the purpose of forming a limited liability company under
Florida Limited Liability Company Act, hereby adopt the following Articles of the Florida Limited Liability Company Act, hereby adopt the following Articles of Organization:

### ARTICLE I

The name of the company (hereinafter referred to as the "Company") is: WSC INSPECTION SERVICES, LLC.
