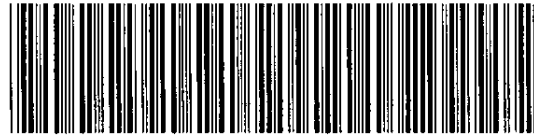

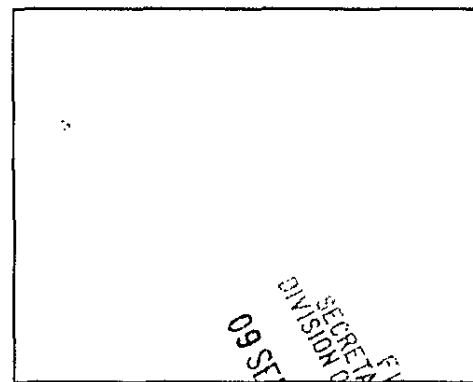

1. The name of the limited liability company is Prime Kurtell Properties, LLC (the "Company").
2. The Articles of Organization of the Company were filed with the Florida Secretary of State on December 3, 2003 and assigned Florida document number L03000050327.
3. The following text is hereby adopted as Section 14 of the Articles of Organization of the Company:

Notwithstanding any provision of the Florida Limited Liability Company Act to the contrary, each Member of the Company shall be personally liable for all of the debts, obligations, and liabilities of the Company and each such Member shall be liable to the same extent as a general partner in a general partnership.
