

ARTICLES OF ORGANIZATION

of

"CommVest Realty, LLC"

The undersigned, desiring to form a Limited Liability Company pursuant to the Florida Limited Liability Company Act ("Act"), does hereby make, acknowledge, and file the following Articles of Organization:

- I. NAME. The name of the limited liability company formed pursuant hereto shall be at all times CommVest Realty, LLC ("Company").


