ARTICLES OF ORGANIZATION OF NELSON CONSTRUCTION, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Elorida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME


