The undersigned, for the purpose of amending and restating in its entirety the original Articles of TE Organization of J&T ASSOCIATES, LLC, a Florida limited liability company, hereby makes, acknowledges, and files the following Amended and Restated Articles of Organization pursuant to the provisions of Section 608.411 Florida Statutes.

## ARTICLE I - NAME

The name of the limited liability company shall be J&T ASSOCIATES, LLC ("Company").

### **ARTICLE II -- ADDRESS**
