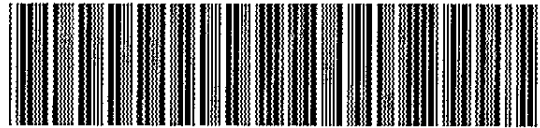

ARTICLES OF ORGANIZATION

SIERRA RANCH, LLC

The following shall constitute the Articles of Organization for **SIERRA RANCH, LLC**, a limited liability company (the "Company"):

- I. **Name:** The name of the Company is SIERRA RANCH, LLC.
- II. **Management:** The Company shall be managed by a manager or Managers, as may be more particularly provided by the Members in the Operating Agreement.
- III. **Address:** The mailing address and street address of the principal office of the Company is 4788 West Commercial Boulevard, Tamarac, FL 33319.
- IV. **Initial Registered Agent:** The name and street address of the initial registered agent for service of process in Florida is Edward J. Schack, 23164 Sandalfoot Plaza Drive, Boca Raton, FL 33428.
- V. **Operating Agreement:** The Company shall be operated in accordance with the provisions of the Operating Agreement which shall be entered by the Members. The Operating Agreement shall govern the admission of new members of the Company, assignability of ownership interests in the Company, termination and dissolution of the Company, distributions, the obligations and rights of the members and any other matters which the Members shall provide therein. Otherwise, the Company shall be governed by Florida law, and in particular the provisions of Chapter 608 of the Florida Statutes.
