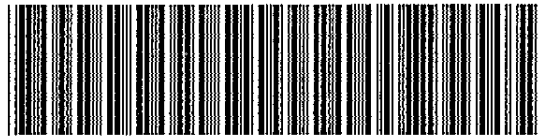

E. John Stockwell, whose address is: 2301 S.E. 16th Street, Cape Coral, Florida 33990.


*ARTICLE VI
