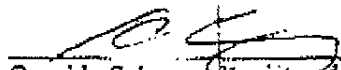

#### ARTICLE V - PERCENTAGE INTEREST AND MEMBERSHIP CERTIFICATE

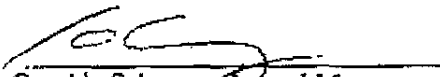

No member shall have the right to assign the member's interest in the company without the written agreement of the majority of the units. The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss deduction, credit or similar item to which assignor was entitled, to the extent assigned.
