Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

- FIRST:** The name and address of this corporation is **JERRY W. POWERS MISCELLANEOUS CONTRACTING LLC**, 2940 Silver Spur Loop, Lake Wales, Florida 33898.
- SECOND:** The date of the adoption of these Articles of Dissolution is 23 February 2009.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
