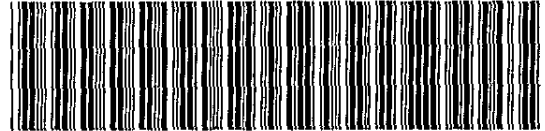

ARTICLE III - ADDRESS

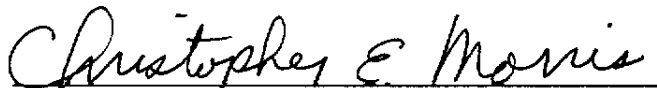

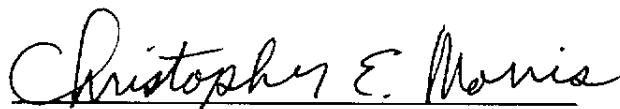
