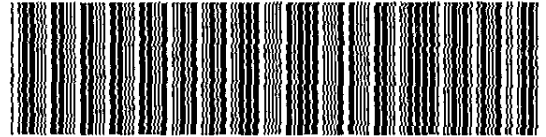

The contribution of a member may be in cash, property or services rendered, or a promissory note or other obligation to contribute cash or property or to perform services.


