1. Name. The name of the limited liability company is INTERTRADE OF FLORIDA, L.L.C. ("Company").

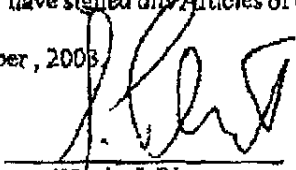

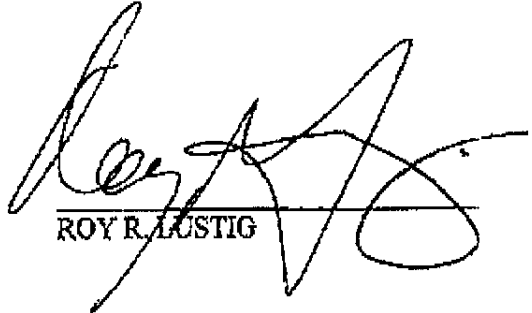
