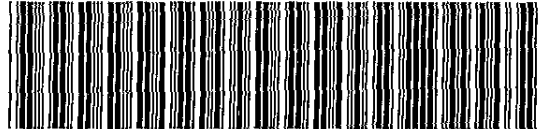

ARTICLE 1 - Name

The name of the limited liability company is Dave's Certified Services, L.L.C.

ARTICLE 2 - Address

The mailing address and street address of the principal office of the limited liability company is: 1380 Rence Ave., Orlando, FL 32825.
