





### ARTICLE V – Division of Ownership

### ARTICLE VI – Amendments to the Articles of Incorporation

Any amendment to these articles requires the approval of all managing members.

### ARTICLE VII – TRANSFER OF OWNERSHIP

1. Transfer of ownership must be approved by all managing members unless ownership rights are transferred to the children or other heirs of the managing member desiring to transfer ownership.
2. Transfer of ownership by sale of a managing member's ownerships right, as listed in Article V, requires approval of all managing members. First right of refusal for the sale of any ownership rights shall be made available to the remaining managing members.
