SECOND: The following amendments to the Articles of Organization of CENTERLINE HOMES AT BALDWIN PARK V, LLC were adopted by the limited liability company:


ARTICLE II is hereby amended as follows:

The street address and mailing address of the Limited Liability Company shall be 825 Coral Ridge Drive, Coral Springs, FL 33071.




