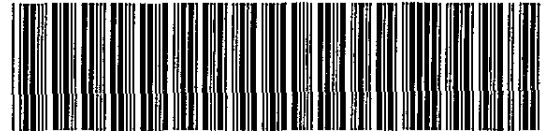



The mailing address and street address of the principal office of the limited liability company is **7315 NW Lake Jeffrey Road, Lake City, Florida 32055**.


## ARTICLE III- INITIAL REGISTERED AGENT

The limited liability company is to be a member-managed company, to be managed by one or more members.

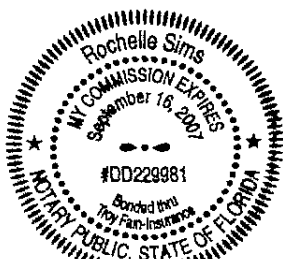


