ARTICLES OF ORGANIZATION
OF
KASTLE CONCEPTS, LLC

The undersigned, acting as the organizer of this Limited Liability Company pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company:

ARTICLE I - NAME

The name of the limited liability company shall be Kastle Concepts, LLC (the "Company").

ARTICLE II - ADDRESS OF PRINCIPAL OFFICE

The mailing address and street address of the principal office of the Company is: 6092 Tarawood Drive, Orlando, Florida 32819.

ARTICLE III - DURATION

The term of existence of the Company shall commence with the filing of the Articles of Organization with the Secretary of State of the State of Florida, and shall continue perpetually unless sooner dissolved pursuant to the Articles of Organization or Regulations of the Company or by operation of law.

ARTICLE IV - PURPOSE AND GENERAL POWERS

The general purposes of this Company shall be the transaction of any or all lawful business for which corporations may be incorporated under law. The Company shall have all of the powers enumerated under law and all such other powers as are not specifically prohibited to corporations for profit under the laws of the State of Florida.

ARTICLE V - MANAGER

The management of the Company shall be reserved to the manager or managers of the Company. The number of managers of the Company shall be the number from time to time fixed by the members, or the managers, in accordance with the terms and conditions of the Operating Agreement of the Company.

The Company shall have an Operating Agreement or Regulations, the amendment of which shall be in accordance with the terms thereof.

ARTICLE VII - REGISTERED OFFICE AND REGISTERED AGENT

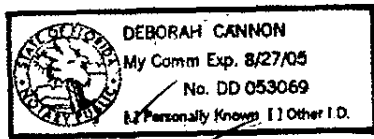
