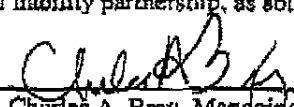
ARTICLE IV MANAGEMENT OF THE COMPANY

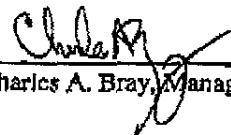

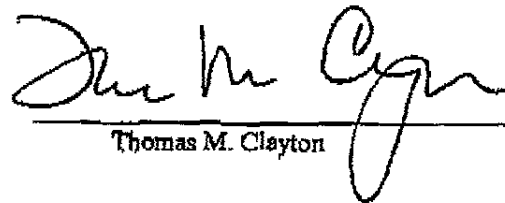
