**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
NAME**

The members shall have the power to adopt, alter, amend, or repeal an Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.


ARTICLE X
