

### ARTICLES OF ORGANIZATION BLACKBURN POINT MARINA VILLAGE, LLC

OS OF LEED AS OF The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be BLACKBURN POINT MARINA VILLAGE, LLC ("Company").

#### ARTICLE II - PURPOSE AND POWER
