ARTICLES OF ORGANIZATION

OF

JAGUAR RESTAURANT GROUP, LLC

The undersigned, for the purpose of forming a limited liability company under the Flortda Limited Liability Company Act, adopts the following Articles of Organization:

ARTICLE I

<u>Name</u>
