## ARTICLES OF ORGANIZATION OF DI-CASTIN, LLC

#### **ARTICLE I -- NAME**

The name of the limited liability company shall be *DI-CASTIN*, *LLC*, ("company").

#### **ARTICLE II -- ADDRESS**
