ARTICLES OF ORGANIZATION
OF
MYRA GROUP, LLC

ARTICLE I -- NAME

The name of the limited liability company shall be **MYRA GROUP, LLC**, ("company").

ARTICLE II -- ADDRESS

The company shall commence its existence on the date these articles of organization are signed. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE V -- CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company the cash or property in the amount of \$500.00 for each of the Members.

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as provided in the regulations.

ARTICLE VII -- ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. ARTICLE IX -- MANAGEMENT


