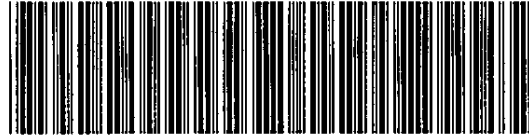

ARTICLE 1
NAME

The name of this limited liability company is Aku Tiki, LLC.

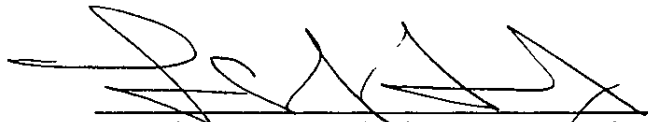
SECOND: The date of filing of the original Articles of Organization of Bahama House, LLC was December 12, 2003, and assigned Florida document number L03000052549.

FOURTH: These Amended and Restated Articles of Organization of Aku Tiki, LLC supersede the original articles of organization and all amendments thereto.

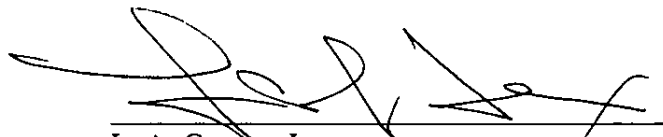
