**ARTICLES OF ORGANIZATION
OF

The undersigned hereby form a limited liability company pursuant to the laws of the State of Florida.

ARTICLE I: NAME

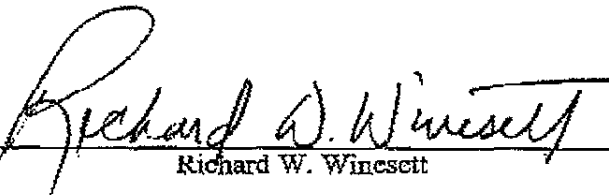

ARTICLE VIII: MANAGEMENT

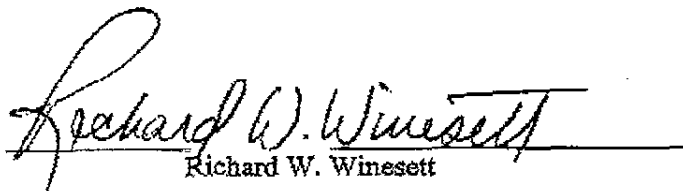
