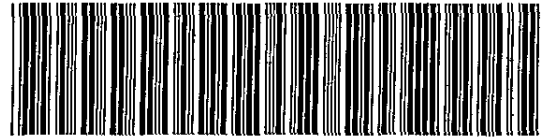



The effective date of the company shall be December 20, 2003.


