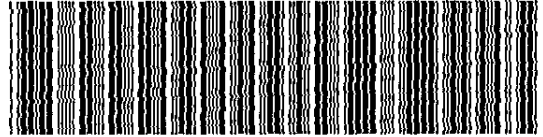

**ARTICLES OF ORGANIZATION**  
**OF**  
**R. K. EUSTACE & ASSOCIATES, L.L.C.**  
**a Florida Limited Liability Company**

**ARTICLE I**  
**NAME**

The name of this Limited Liability Company is R. K. EUSTACE & ASSOCIATES, L.L.C. (the "Company").

**ARTICLE II**  
**ADDRESS**

**ARTICLE III**  
**DURATION**

#### **ARTICLE V ADMISSION OF NEW MEMBERS**

The right, if given, of the members to admit additional members and the terms and conditions of the admissions shall be:

The manager may admit new members in its sole and unfettered discretion subject only to the condition that such additional member must agree in writing to be bound as a member of the Operating Agreement of the Company.

#### **ARTICLE VI MEMBERS RIGHTS TO CONTINUE BUSINESS**

The right, if given, of the remaining members of the limited liability company to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall be:

The death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company shall not terminate the company, and the business of the company shall be automatically continued, so long as there is at least one remaining member.


