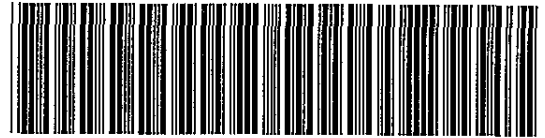


ARTICLE IV


