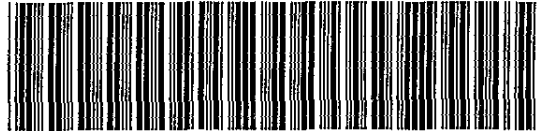



**ARTICLES OF ORGANIZATION OF
MORRIS TAITE GENERAL CONTRACTOR, L.L.C.**

ARTICLE I - NAME

The name of the limited liability company ("Company") is MORRIS TAITE GENERAL CONTRACTOR, L.L.C.

ARTICLE II - ADDRESS

The mailing and street address of the Company's principal office is 2020 N.E. 135th Street, Suite 807, North Miami, Florida 33181.

ARTICLE III - DURATION

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

ARTICLE IV - REGISTERED AGENT & OFFICE

The name of Company's initial registered agent in Florida is KENNETH N. REKANT. The address of Company's registered office in Florida is 333 41st. Street, Suite 506, Miami Beach, Florida 33140.

ARTICLE V - MANAGEMENT

The Company is to be managed by a member who will serve until the first annual meeting of the members. The manager is MORRIS TAITE.

ARTICLE VI - ADMISSION OF NEW MEMBERS

Individual members of the Company have no right to admit new member(s). the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining members.

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the persons listed in Article V above.
