### Article V- Distribution of Membership Units

Each of the following investors in Gatorbuyback.com, L.L.C. will receive membership units that are proportional to the amount of capital that they invest in Gatorbuyback.com. Each membership unit corresponds to 1% of equity in the company. Membership units are currently allocated at the rate of one membership unit for every \$500 dollars invested or spent or behalf of Gatorbuyback.com.
