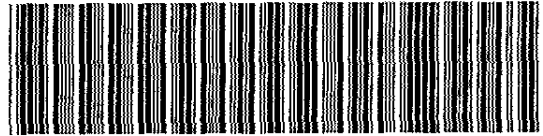

The name of this Limited Liability Company is Sunbelt Custom Painting, LLC.


ARTICLE II--ADDRESS
