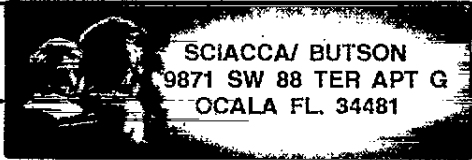

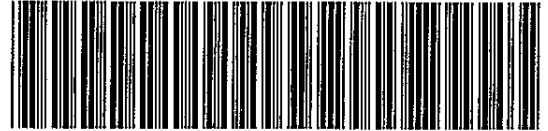

**MEMBERS' OPERATING AGREEMENT FOR**  
**CARCO BUILDERS, LLC**

COME NOW, the parties listed below and stipulate and agree as follows:

1. Don Shindler previously received a 45% interest and Franklin Friedman a 45% interest in the LLC, effect March 31, 2005 and this document is designed to reflect that ownership interest. Carl Sciacca remains as a member have a 10% interest in the CARCO BUILDERS, LLC hereinafter, the "LLC."
