The undersigned, acting as a Managing Member of Carco Builders, LLC, a Limited Liability Company under the Florida Limited Liability Company Act, adopts the following Articles of Organization for such company:

ARTICLE I - NAME: The name of this Limited Liability Company is Carco Builders, LLC.

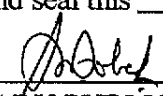
