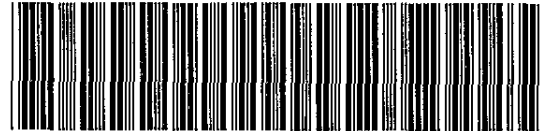

**ARTICLES OF ORGANIZATION  
OF  
SAIL ON, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under Chapter 608, Florida Statutes, the Florida Limited Liability Company Act.

**Article 1 – Name**

The name of the limited liability company is Sail On, LLC (the “Company”).

**Article 2 – Address**

The mailing address and street address of the principal office of the Company is 24 Dockside Lane, #145, Key Largo, FL 33037.


**Article 3 – Duration**

### **Article 7 – Management of the Company**


